Terms And Conditions

The parties herein agree as follows:

1a. The fee per visit of \$23.00 plus the number of miles to and from the Complete Pet Care Animal Hospital and the client's house (at .56 cents per mile). All payments should be made payable to the Complete Pet Care Animal Hospital.

Contracted Rate: (Subject to change with notice by Complete Pet Care Animal Hospital.)

PAYMENT IS DUE IN FULL PRIOR TO SERVICE

If client desires to pay by check, they are required to provide Complete Pet Care Animal Hospital with a valid social security number and driver's license number. If client prefers to pay via credit card, they are required to provide a valid credit card and expiration date to Complete Pet Care Animal Hospital so that they may be billed before the service is provided.

- 1b. Expenses incurred by the pet sitter for items, including extra pet food, litter, garbage bags, household cleaners, etc. shall be billed to the client immediately following the client's return home. The client is responsible for reimbursing Complete Pet Care Animal Hospital for these expenses immediately upon their arrival.
- 2. Any additional visits made, or services performed, shall be paid for at the agreed contracted rate. For four or more pets, there will be an extra charge of \$2.00 per pet. In the event of early return home, the client must notify the pet sitter promptly to avoid being charged for unnecessary visit(s).
- 3. A cancellation fee of twenty percent of the total original bill will be charged if the client cancels the pet sitting arrangements prior to the first visit. If the client cancels prior to the initial meeting, they will be charged a \$10.00 cancellation fee.
- 4. The pet sitter is authorized to perform care and services as outlined on this contract. The pet sitter is also authorized by the client's signature below to seek emergency veterinary care with release from all liabilities related to transportation, treatment, and expense. Should a specially specified veterinarian be unavailable, Complete Pet Care Animal Hospital will provide any necessary treatment. The pet sitter is authorized to approve any medical treatment excluding euthanasia as recommended by a veterinarian. The client agrees to reimburse the Complete Pet Care Animal Hospital for any expenses incurred, plus any additional fees for their services.

Terms And Conditions

- 5. In the event that inclement weather or natural disaster prohibits the pet sitter from performing their duties, the pet sitter and Complete Pet Care Animal Hospital are entrusted to use their best judgment in caring for your pet(s) and home.
- 6. The pet sitter agrees to provide the services stated in this contract in a reliable, caring, and trustworthy manner.
- 7. In the event of personal injury or illness of the pet sitter, the client hereby authorizes the pet sitter and Complete Pet Care Animal Hospital to arrange for another qualified, hospital employee, to fulfill responsibilities as set for on this contract. The client will be notified in such a case.
- 8. All pets are to be currently vaccinated for Rabies. Other vaccinations are highly recommended for your pet's safety. Should the pet sitter be bitten or otherwise exposed to any disease from the client's animal, it will be the client's responsibility to pay for all costs and damages incurred by the victim.
- 9. The pet sitter and Complete Pet Care Animal Hospital reserve the right to terminate this contract at any time before or during its term if it is determined that the client's pet poses a danger to the health and safety of the pet sitter. If any concerns prohibit the pet sitter from caring for the pet(s), the client authorizes the pet(s) to be placed in a boarding kennel. All costs incurred in such a case will be billed to the client.
- 10. The client will ensure that neighbors/landlords are aware of when the pet sitter will be caring for the pet(s) to ensure that the pet sitter experiences no problems entering the premises. Any delays and/or additional time spent by the pet sitter to care for the client's pet(s) due to problems entering the client's house will be billed to the client at a rate of thirty-two dollars per hour.
- 11. The client authorizes this signed contract to be valid approval for future services of any purpose provided by this contract. The pet sitter and Complete Pet Care Animal Hospital, therefore, will be permitted to accept telephone reservations for future service.
